Adjusting Years of Service

- Year one in ftwilliam is very important
 - Plan calculations form the basis for future years
 - Applies whether it's a takeover or conversion plan
- It's vital that eligibility & entry dates, years of service and HCE/Key indicators are all calculated or imported correctly



- PRIOR years of service, i.e. prior to the current year, are calculated based on date of hire & hours worked in the current year
 - E.g. 2014 plan, January 2010 hire date, 1000 hours worked in 2014. Prior YOS = 4
 - E.g. 2014 plan, January 2010 hire date, 800 hours worked in 2014. Prior YOS = 0
- May need to adjust prior YOS on *ftw first year supplemental grid



- Prior YOS are held at source level
 - 1. Elective deferrals
 - 2. Match
 - 3. Profit sharing
 - 4. Disaggregation
 - 5. Vesting
- 1 4 are used to calculate eligibility & entry dates
- 5 (Vesting) is used to calculate vesting percentage vesting will always be incorrect if the vesting YOS are not correct in year 1

- Order is important
 - Upload primary census
 - Adjust prior YOS in *ftw first year supplemental grid
 - Run data scrub
 - If scrub is run before adjusting YOS
 - Re-upload data and on submit screen select Yes for the reset eligibility dates option



- Cannot override by entering zero in PYoS field if a participant has zero years & is not calculating correctly, modify primary grid by adding another hours field
 - 'R:Service_EligibilityHoursInitial'. For anyone who worked 1000 hours for the first time, enter 0 in the first hours column and 1000 in this new column OR
 - Override initial eligibility using *ftw Override Initial eligibility grid



Adjusting Years of Service - Conversion plans

- Typically years of service are downloaded from prior record keeper and uploaded to ftwilliam.com
- Important to verify that YOS are correct



Adjusting Years of Service - Conversion plans

 May need to adjust YOS for those who have not reached their first anniversary by the beginning of the conversion year

WHY WHEN AND HOW?

Why Override Eligibility?

- Global Overrides
 - Importing eligibility & entry dates from prior system
- Individual Overrides
 - Complex employment history for one or two participants
 - Insufficient information for the software to calculate accurately for all participants
 - Eligibility is based on a specified number of hours
 - There's an hours requirement over a period other than a full calendar year
 - Eligibility provisions have changed
 - Entry dates are not in line with PYE e.g. fiscal year and calendar year period entry dates



Overriding Eligibility Globally

- Go to Scrub/Eligibility Parameters screen there are four eligibility overrides
 - The first two flip to Yes the first year in ftwilliam
 - Change the third one to yes if you want to globally override the system calculation of eligibility/entry dates

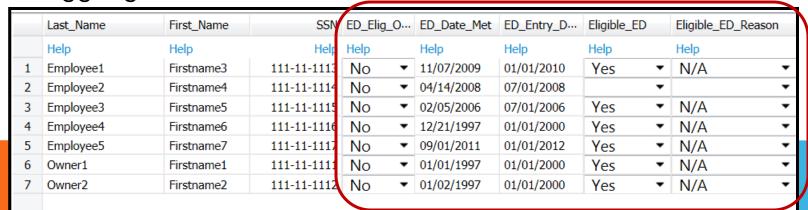


Overriding Eligibility Globally

- Upload eligibility and entry dates a couple options are either:
 - *ftw DER Conversion as the primary grid (only in conversion year)
 - *ftw Override Initial Eligibility as a supplemental grid and manually edit the data

Global Overrides - *ftw Override Initial Eligibility

- Five columns for each source set all sources
 - ED_Elig_Override Global, no need to change this; 'No' is fine
 - ED_Date_Met enter the correct date
 - ED_Entry_Date enter the correct date
 - Eligible_ED select Yes or No
 - Eligible_ED_Reason select reason if not eligible or N/A
- Override all fields for each applicable source and disaggregation of OEE





Individual Overrides

- Use when there's no other option, e.g. complex employment history, lack of data, change in eligibility provisions
- Note: For eligibility issues related to incorrect data in current or prior years, we strongly recommend correcting the incorrect data to correct the eligibility, not use overrides



Individual Overrides

- Do not use the global override run the scrub and let the software calculate eligibility
- Review results
 - Adjust the dates you need to change using new supplemental grid
 - * ftw Override Initial Eligibility this grid sets individual participant override



Individual Overrides

- If you only have a few items to add you can click the 'Edit Data' link next to the grid and add the data directly into the grid
- If you have more data you can click the 'Download' link to save the grid in spreadsheet format, add your data to the worksheet, save and upload
 - Use 'Upload No Map'



Individual Overrides -*ftw Override Initial Eligibility

- Five columns for each source set all sources
 - ED_Elig_Override Must set to Yes
 - ED_Date_Met enter the correct date
 - ED_Entry_Date enter the correct date
 - Eligible_ED select Yes or No
 - Eligible_ED_Reason select reason if not eligible or N/A
- Override all fields for each applicable source and disaggregation of OEE

Estimating Future Eligibility Dates

- "We send clients with one YOS requirement for eligibility the names of employees that may be eligible on the next entry date; the client reviews and orders enrollment kits
- Since ftwilliam does not calculate future eligibility dates, we manually calculate the dates in Excel
- Do other TPAs offer this service? How do you calculate and advise the client of future enrollees?"



Estimating Future Eligibility Dates

- ftw suggest creating a custom grid with the following fields and adding on the Other Imports/Exports/Reports screen:
 - LastName
 - FirstName
 - SSN
 - BirthDate
 - EarliestHireDate
 - LastDayStatus
 - Eligible_ElectiveDeferralEntryDate
 - EmployeeClass
 - Service_EligibilityHours



Estimating Future Eligibility Dates

- Download data .csv/Excel
- Sort by entry date; delete ppt's with valid entry date
- Sort by last day status; delete ppt's who are terminated
- Sort by date of birth; delete ppt's who are too young
- Sort by date of hire; add one year to date of hire and manually evaluate eligibility
