RMD FUNCTIONALITY

RMD Overview

- Software will calculate required beginning dates and required minimum distribution amounts
- Need census data and transactions added & posted
- Data scrub and statements (or one of the vesting reports) must be run
- Can be run globally, across all plans, or one plan at a time

- Screen will list all ppts who are 70 1/2 at plan year end
- First do calculations, then run reports





- See error list most common error is invalid beneficiary DOB
- Software does not change table even if beneficiary is 10 years younger





- Most common error is no prior year balance
- Second screen shot above is a good thing to see!

Overrides

- Click on 'Edit (year) Data' link to override end of prior year account balance
- Click on 'Edit Participant Master File Data' to:
 - Add beneficiary birth date
 - Override calculation of RBD
 - Change life expectancy table
 - Need to change table if spouse is more than ten years younger
- If there's no RBD, edit data link will not be active



Print Report

- Once you have run the RBD and RMD calculations you can print the reports
- Reports are available as a web page, or a CSV file
 - Web page can be pasted into Word landscape works best

CENSUS GRIDS

Grid Problems – Census will not Upload

- Grid ID in cell A3 does not match that of the grid selected for the plan
- Data does not begin on row 6 of spreadsheet default on upload screen is to ignore 5 rows
- There's a duplicate field on the census grid
 - One system field selected twice may have different descriptions
- Employee number column populated with numbers formatted as SSNs
- User has switched ppt identifier SSN/EEN
 BIG NO NO



Grid Problems - Multiple Error Messages on the Scrub

- Not using one of the grids designed as a primary census grid – note these can be customized
- Current primary census grids are:
 - Sample Census (comp and comp after elig) (c5debf8) for plans using entry date compensation
 - Sample Census Data full year comp (9ad7af9) for plans using full year compensation
 - Sample Census exclude certain comp(414s comp test) (6642cbb) - for plans using non 414(s) compensation
 - Sample Census Data fiscal yr (9e9fe1e) for non calendar year plans



Grid Problems - Multiple Error Messages on the Scrub

- User deletes important columns from the grid
 - If plan uses full year comp, start with that grid
 - Hours are still required even if the plan uses elapsed time for eligibility
- Not populating all compensation or hours fields on your grid
- Messing up the mapping ③



New Grid Functionality

- Grids can now be deleted by users who are designated admins
 - Use with caution if grid has been used as a primary grid
- A new 'check for duplicate fields' feature has been added
 - a warning will trigger if you try to add a field to a grid that is already in grid
 - Old grids will still need to be reviewed for duplicates



 New message triggers if you try to add a field that is already in the grid





New Grids Available

- We have designed a new set of grids to eventually replace the old 'sample' grids
 - These will be known as 'System Grids'
- System grid names will begin with * ftw
- New customers will have only the system grids added starting immediately
- Current customers will see the system grids as well as their current grids but at the bottom of the list.



New Grids Available

- Highlights of differences are:
 - Fields streamlined fields removed or rearranged e.g. Employee Number removed
 - Will need to replace the SSN field with EEN field if not using SSN.
 - Heading & Help Text fields are more descriptive
 - System grids cannot be edited
 - Copy, change short description then modify
 - System grids cannot be deleted
 - Copies of system grids can
